**DIRECTIONS to the Hawthorne Inn**

2421 Wilbur Cross Parkway (Berlin Turnpike), Berlin, CT 06037  
(860-828-3571)

**From Hartford:** Follow I 91 South to Exit 22 N toward New Britain. Then take another exit 22 (Rt. 15). Take a right at end of ramp and at next light take another right. At the next light take a left and bear right onto Berlin Turnpike (Rt. 15 South). Hawthorne Inn will be about 2 miles on left.

**From New Haven:** Follow I 91 North to exit 17. Stay in left lane and follow signs for Berlin Turnpike (Rt. 15). Hawthorne Inn will be about 3 miles on right hand side.

OR

Take Wilbur Cross Parkway (Rt. 15) all the way and once you reach Meriden, Hawthorne Inn will be about 4 miles on the right hand side.

**From Waterbury:** Take I 84 East to Rt. 691 East. Take exit 8 of 691, take right off ramp and Hawthorne Inn will be about 3 miles on the right hand side.

**From Old Saybrook and Middletown:** Take Route 9 North toward New Britain to Exit 22. Take a right at end of ramp and at next light take another right. At the next light take a left and bear right onto Berlin Turnpike (Rt. 15 South). Hawthorne Inn will be about 2 miles on left.
